THE ISRAELI NUCLEAR THREAT

Draft resolution submitted by Algeria, Iraq,
the Islamic Republic of Iran, Jordan, Kuwait, Lebanon, Madagascar,
Morocco, Namibia, Saudi Arabia, Sudan, the Syrian Arab Republic,
Tunisia and the United Arab Emirates

The General Conference,

- (a) Having considered agenda item 7 and the document GC(XXX)/778,
- (b) <u>Having considered also</u> the annual report of the Agency for 1985, and in particular paragraph 40,
- (c) <u>Bearing in mind</u> United Nations General Assembly resolution 40/82 on the establishment of a nuclear—weapon—free zone in the region of the Middle East,
- (d) Bearing in mind also Security Council resolution 487 (1981), which inter alia called upon Israel urgently to place its nuclear facilities under International Atomic Energy Agency safeguards,
- (e) Noting United Nations General Assembly resolution 40/93 on Israeli nuclear armament, which — inter alia — called upon Israel to place all its nuclear facilities under Agency safeguards and to renounce any possession of any nuclear weapons,
- (f) Noting further the United Nations Secretary-General's reports on Israeli nuclear armament document A/36/431 of 1981 and document A/40/520 of 1985,

- (g) Bearing in mind the relevant resolutions of the United Nations General Assembly concerning the co-operation between Israel and South Africa, particularly in the nuclear field, and
- (h) Alarmed that the unsafeguarded nuclear facilities in Israel which are capable of producing material usable for nuclear weapons are detrimental to the establishment of a nuclear-weapon-free zone in the Middle East,
 - 1. Affirms the necessity to establish a nuclear-weapon-free zone in the Middle East,
 - 2. <u>Demands</u> that Israel submit forthwith all its nuclear facilities and installations to International Atomic Energy Agency safeguards,
 - 3. Calls upon all States that have not yet done so to discontinue co-operating with and giving assistance to Israel in the nuclear field as long as Israel does not comply with the provisions of this resolution,
 - 4. Requests the Board of Governors and the Director General to take the measures necessary for the implementation of this resolution.
 - 5. Further requests the Board of Governors and the Director General to follow closely the activities and evolution of Israel in the nuclear field and to report to the General Conference at its 31st regular session on Israel's nuclear capability, and
 - 6. <u>Requests</u> the Director General also to bring this resolution to the attention of the Secretary-General of the United Nations.
